



## Purpose

The purpose of this incentive is to acknowledge and reward our Lottery Retailers and Lottery Retailer employees for their engagement during our LTR Training Events throughout the province of British Columbia.

## Definitions

- **“BCLC”** means the British Columbia Lottery Corporation.
- **“Drawn Entrant”** means a Lottery Retailer or Lottery Retailer employee selected to win a prize.
- **“LTR Training Event”** means one of the thirteen (13) training sessions hosted by BCLC to provide hands-on training to Lottery Retailers and their employees with respect to lottery terminal replacement (LTR).
- **“Module”** means the Social Point quiz that will correspond to the learning stations during the LTR Training Event.
- **“Social Point”** means the third-party vendor that will be executing the quizzes and tracking the results.

## Eligibility

- Any Lottery Retailer or any employee of a Lottery Retailer.

## Prize(s)

**How to Enter**

- A Lottery Retailer or Lottery Retailer employee will receive one (1) entry (“**Entry**”) to a draw to win a Prize by:
  - attending an LTR Training Event;
  - completing a Module with a score of 80% or higher; and
  - entering their first name, last name and email address on Social Point.
- Attendees at each LTR Training Event will be able to scan a QR code that will direct them to the Social Point platform.
- Maximum of five (5) entries per person.

**Draws**

- 142 draws will be conducted from the pool of Entries within one week of completion of the last LTR Training Event on May 1, 2024, or as soon as practical thereafter.
- The number of Prizes available to be won at each LTR Training Event will be determined based on the attendance at each LTR Training Event.
- Each Prize is awarded directly to the Drawn Entrant.

**Draw Procedure**

- Each draw will be conducted by an authorized BCLC representative accompanied by one (1) witness who is at least 19 years of age or older.

**Prize Redemption**

- The Drawn Entrants will be notified via email and/or phone that they have won a Prize.
- In order to redeem and receive the Prize, a Drawn Entrant must be qualified to win in accordance with these Incentive conditions.
- All winning prize delivery arrangements will be made directly with the Drawn Entrant.



### **Other Conditions**

- Odds of winning a Prize depend on the number of entries received during the LTR Training Event.
- Participants may only win one prize per LTR Training Event.
- BCLC may, at its sole discretion, disqualify Lotto Retailers and Site Employees that do not comply with these conditions.
- BCLC may, at its sole discretion, alter, amend, suspend, or cancel this incentive or these incentive conditions at any time.
- BCLC reserves the right to substitute a Prize or portion thereof with one of equal or greater value. The prize must be accepted as awarded.
- BCLC reserves the right to publish the name, location, and a recent photograph of a Drawn Entrant and associated networks, in any medium, without remuneration.
- In the event of a discrepancy between the results of the draws posted on the Retailer Hub and the official information from British Columbia Lottery Corporation, the latter will prevail.
- Decisions of BCLC are final and binding.
- By participating in this Incentive, each Lottery Retailer and Lottery Retailer employee agrees to release and discharge, and agrees to indemnify, save and hold harmless BCLC and its directors, officers, employees, affiliates, agents and representatives (the "Releasees") from and against any and all actions, claims or demands (including costs incurred by BCLC in defending such actions, claims or demands) which they may now or hereafter have against the Releasees, or any of them, arising directly or indirectly out of, or which are in any way connected to this Incentive.
