What is the purpose of this Player Health Training Incentive?

Why is Player Health Training important?

Player Health Training has been developed to provide lottery retailers with the skills to recognize and respond to customers who may show concerning behaviours with gambling.

We know retailers have encounters with customers that may sometimes cause discomfort or concern. This training aims to help retailers gain the knowledge they need to feel confident when responding to these situations. It also highlights the support that is available to the retailer should they need someone to talk to directly.

Do I have to take part in this Incentive?
