Definitions:

- **“Eligible Purchase”** means a purchase of \$15 or more on any lotto products at an Eligible Retailer, which qualifies a player to participate in the promotion.
- **“Eligible Retailer”** means a Retail Stores Group (“RSG”) retailer who:
 - a) sells BCLC lottery products;
 - b) is in good standing with BCLC on October 26, 2025, at 23:59:59 PT, and remains so throughout the Promotional Period;
 - c) is registered with the Gaming Policy and Enforcement Branch; and
 - d) has completed the BCLC Retailer certification.
- **“Participating Lotto products”** means all lottery games, Scratch & Win, Proline, Keno, and Web Cash.
- **“Promotional Period”** means the period from October 27, 2025 at 00:00:00 (midnight) PT to 23:59:59 PT on December 7, 2025.
- **“Winner”** means a player whose eligible Entry is selected to receive an Entry into the Grand Prize draw, or the Grand Prize in this Promotion.

Eligibility:

- To be eligible, a player must be an individual 19 years of age or older, who is geographically located within British Columbia throughout the Promotional Period, and who is not (i) a BCLC employee; (ii) a participant in a BCLC voluntary self-exclusion program, (iii) who enrolls in a BCLC voluntary self-exclusion program during the Promotional Period; (iv) barred from a BCLC casino or Community Gaming Centre or PlayNow.com at any time during the Promotional Period; (v) an Eligible Retailer; (vi) an Eligible Retailer employee; or (vii) a family or household member of a BCLC employee, Eligible Retailer or Eligible Retailer employee.

How to Enter:

- Eligible Entries:
 - Players who make an Eligible Purchase will get a chance to submit one (1) entry (the “Entry”) to enter for a chance to win a Grand Prize. Players must visit https://bclcfamilyreunioncontest.tbts.me/tb_app/527248 or scan the QR code available at an Eligible Retailer and complete the information required in the online form located in the *Tradable Bits* platform. Players will need to submit their first name, last name, phone number, and a complete picture of the front of their receipt to be eligible for the Grand Prize Draw.
 - Players may also download one (1) no purchase necessary entry ballot on www.playnow.com/lottery/promotions/retail-lottery-promotions and send it to BCLC’s Vancouver Office at 2940 Virtual Way, Vancouver, BC V5M 0A6Attn: Trade Marketing. Mail-in submissions must be received by December 7, 2025.
- Players may receive a maximum of one (1) entry per Eligible Purchase and one (1) no purchase necessary entry ballot per day during the Promotional Period.
- Only unique receipts will be accepted. Receipts cannot be submitted multiple times in different days.

Grand Prize Draw:

- A draw to select one (1) Winner from all eligible Entries collected from all Eligible Retailers will be conducted by BCLC on December 12, 2025, or as soon as practicable thereafter.
- All eligible entries will be entered into the Grand Prize draw.

Grand Prize:

Description

The Grand Prize consists of a travel experience valued at up to \$7,500 CAD, inclusive of all applicable taxes and fees. The winner may choose one of the following options, subject to eligibility and availability:

1. **Family Reunion Trip:** A trip for two (2) people to visit the winner’s parents or children anywhere in the world for up to five (5) days. This option includes:
 - Round-trip economy airfare for two (2) people.

- Standard accommodation (double occupancy).
 - Ground transportation to and from the departure airport.
 - A daily travel allowance of \$200 CAD (maximum \$1,000 CAD total).
 - All travel arrangements must fall within the total prize value of \$7,500 CAD.
- 2. Alternative Trip (for B.C. Residents with Family in B.C.):** If the winner and their parents or children all reside in British Columbia, the winner will receive a trip for four (4) people to an all-inclusive resort in Cancun, Mexico. This option includes:
- Round-trip economy airfare for four (4) people.
 - All-inclusive resort accommodation.
 - Ground transportation to and from the departure airport.
 - All arrangements must fall within the total prize value of \$7,500 CAD.
- 3. Extended Family Option:** If the winner does not have living parents or children, they may:
- Visit an extended family member (e.g., sibling, grandparent, cousin) or friend under the Family Reunion Trip structure, or
 - Invite extended family members or friends to join the Cancun trip, subject to the same \$7,500 CAD cap.

Prize Conditions and Restrictions:

- The Grand Prize (or any portion thereof) cannot be assigned, transferred, sold, loaned, leased, rented, pledged, mortgaged, hypothecated, or exchanged for cash.
- The Grand Prize will be administered by BCLC or a designated third-party travel agency partner.
- The Grand Prize Winner must coordinate with the designated administrator to finalize travel arrangements within thirty (30) days of being notified.
- Travel must commence within ninety (90) days of the Draw. Failure to complete booking or begin travel within this timeframe may result in forfeiture of the prize, unless otherwise approved by BCLC due to personal, medical, or administrative reasons. In all cases, travel must be completed within one (1) year of notification.
- The Grand Prize Winner and their guest(s) must begin their travel within ninety (90) days following the Draw, unless an extension is granted.
- The Grand Prize Winner is responsible for:
 - Ensuring they and their guest(s) possess all required travel documentation (e.g., valid passports, visas, vaccinations).
 - Any fees, medical costs, or travel-related expenses not expressly included in the prize.
 - Providing proof of relationship and residency of the relative(s) they intend to visit.
 - Complying with all airline, travel agency, and destination-specific requirements, restrictions, and regulations.
 - Any additional costs incurred if the selected itinerary exceeds the \$7,500 CAD prize value. In such cases, the winner may either modify the itinerary to stay within budget or pay the difference directly to the travel agency.

Prize Value and Budget Control:

- The total maximum value of the Grand Prize is \$7,500 CAD. No cash alternative or refund will be provided if the actual cost of the trip is less than this amount.
- BCLC will provide the travel agency with a fixed budget and will approve all itineraries to ensure compliance with the prize cap.
- A pre-approved itinerary will be available for the Cancun trip option.

Odds of Winning:

- The odds of winning depend on the number of eligible entries received.

Grand Prize Claim:

- A BCLC representative will contact the Grand Prize Winner after the draw. The Grand Prize Winner must accept the Grand Prize within five (5) days of first contact by the BCLC representative. If the Grand Prize
